

California Privacy Disclosures

To help California consumers make informed privacy decisions and compare practices across businesses, the state has created a common framework for businesses to talk about privacy. Keyboard Logic is using that framework here to describe, for each category of personal information under California law, whether Keyboard Logic collects that personal information, or shares or discloses it for a business purpose. Keyboard Logic does not sell your personal information.

Keyboard Logic Privacy Policy

- Identifiers: Keyboard Logic collects information that identifies you to provide you with Services that you request. Keyboard Logic discloses this information to our service providers who process the information on our behalf to help us perform a particular business purpose in accordance with our instructions. In some cases, Keyboard Logic may provide this information to third parties for the business purposes requested by you.
- Characteristics of protected classifications under California or federal law: California and federal laws provide protection against discrimination if you belong to a protected class. Protected classes include groupings based on race, ethnicity, or national origin; family status; and whether you have a disability.
- **Commercial information**: Keyboard Logic collects and maintains a record of your transactions with Keyboard Logic, such as the Services that you have purchased. Keyboard Logic shares this information with our service providers for our business purposes. Keyboard Logic also shares certain commercial information with third parties, such as credit card companies, in order to process your transactions.
- **Biometric information**: Under California law, biometric information includes any physiological or behavioral characteristics that can be used to establish your identity. Keyboard Logic does not collect your biometric information.
- Network activity information: Keyboard Logic collects certain information about user activity on our electronic networks, such as how consumers interact with our Services. We use this information to help determine what pages or features are popular or where our products and services could be improved. We may also use such information for marketing purposes with your consent or other applicable legal basis.
- **Geolocation data**: Geolocation data at Keyboard Logic is data that describes a consumer's precise location. Keyboard Logic may collect information about your location to provide you Services that you request.
- Audio, electronic, visual, thermal, or olfactory information: Keyboard Logic does not collect information about your senses.
- **Employment information**: We collect any professional or employment information that you share with us or direct others to share with or make available to us.



- **Education information**: We collect any education information that you share with us or direct others to share with or make available to us.
- Inferences from your personal information to create a profile about your preferences: If you choose to personalize your Services where such an option is available, Keyboard Logic will use information that we collect so that we can offer you those personalized Services.
- **Personal information described in Section 1798.80(e)**: The California Consumer Privacy Act requires that we tell you whether we collect any personal information that is described in California Civil Code Section 1798.80(e). The Code section includes a broad variety of categories of personal information, such as name, contact information, physical characteristics, credit card or billing information, health or medical information, and more. Keyboard Logic collects personal information described in Section 1798.80(e).

Any personal information that Keyboard Logic holds may also be used to comply with applicable law.

California Privacy Rights

California consumers have a right to knowledge, access, and deletion of their personal information under the California Consumer Privacy Act. California consumers also have a right to opt out of the sale of their personal information by a business and a right not to be discriminated against for exercising their California privacy rights. Keyboard Logic does not sell the personal information of California consumers and does not discriminate in response to privacy rights requests.

Keyboard Logic provides notice of our privacy practices in our Privacy Policy. The Privacy Policy includes what personal information is collected, the source of the personal information, and the purposes of use, as well as whether Keyboard Logic discloses that personal information and if so, the categories of third parties to whom it is disclosed.

If you do not have a Keyboard Logic account, Keyboard Logic will ask you for information that we consider necessary to verify your identity for security and to prevent fraud. This information may include name, contact information, and information related to your transaction or relationship with Keyboard Logic, but the specific information requested may differ depending on the circumstances of your request for your security and to protect privacy rights. If we delete your personal information, we will both render certain personal information about you permanently unrecoverable and also deidentify certain personal information.



Do Not Track

Keyboard Logic does not track its customers over time and across third-party websites to provide targeted advertising and therefore does not respond to Do Not Track (DNT) signals. Third parties that have content embedded on Keyboard Logic's websites such as a social feature or a stock ticker may set cookies on a user's browser and/or obtain information about the fact that a web browser visited a specific Keyboard Logic website from a certain IP address. Third parties cannot collect any other personally identifiable information from Keyboard Logic's websites unless you provide it to them directly.
